PZ/LPA Z 22-01, A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF HAMPTON, FLORIDA, SERVING AS THE PLANNING AND ZONING BOARD OF THE CITY OF HAMPTON, FLORIDA, AND THE LOCAL PLANNING AGENCY OF THE CITY OF HAMPTON, FLORIDA, RECOMMENDING TO THE CITY COUNCIL OF THE CITY OF HAMPTON, FLORIDA, APPROVAL OF AN AMENDMENT OF TEN OR MORE CONTIGUOUS ACRES OF LAND TO THE OFFICIAL ZONING ATLAS OF THE CITY OF HAMPTON LAND DEVELOPMENT REGULATIONS, PURSUANT TO AN APPLICATION, Z 22-01, BY THE PROPERTY OWNER OF SAID ACREAGE; PROVIDING FOR REZONING FROM RESIDENTIAL, SINGLE FAMILY/MOBILE HOME-1 (RSF/MH-1) TO COMMERCIAL, GENERAL (CG) OF CERTAIN LANDS WITHIN THE CORPORATE LIMITS OF THE CITY OF HAMPTON, FLORIDA; REPEALING ALL RESOLUTIONS IN CONFLICT; AND PROVIDING AN EFFECTIVE DATE

LANDS WITHIN THE CORPORATE LIMITS OF THE CITY OF HAMPTON, FLORIDA;
REPEALING ALL RESOLUTIONS IN CONFLICT; AND PROVIDING AN EFFECTIVE
DATE
