In order to open a new account a **\$100.00 deposit** will be required. All new water connections will have to pay an additional **\$25.00 connection fee**.

In the event of termination of water service due to non-payment, all fees and costs owed must be paid in full to have water service restored. There will be a **\$25.00 reconnection fee**.

All water bills are due by the 5th of the month. A **late fee** charge of **\$7.50** will be applied to all accounts paid after the 5th of each month.

No account will be able to carry a past due amount of more than **\$100.00**.

In such cases where disconnection of water service is a frequent reoccurring issue an additional deposit of **\$100.00** may be required..
